Carrier	Guidelines
	<p>Must be the sole carrier confirmed by an attestation form</p> <p>Must be complete at submission with all requirements in by 12/15 midnight - no exceptions</p> <p>Recertification at renewal: Yes, to ensure group meets the definition of a small employer</p> <p>Ancillary coverage will follow normal guidelines for participation and contribution</p>
	<p>Must be the sole carrier</p> <p>Must be complete at submission with all requirements in by 12/14 by 4 pm</p> <p>Dental/Vision will follow the guidelines if sold with medical and at least 2 are enrolling</p> <p>Recertification at renewal: No, as these groups are part of the Special Open Enrollment window</p>
	<p>Can be written alongside another carrier's HMO only, another carrier's HMO and MediExcel only, or another carrier's HMO and SIMNSA only. Regular underwriting guidelines apply</p> <p>Must be submitted to Blue Shield by 5:00 pm on 12/17 and approved within 30 days of submission</p> <p>Dental/Vision follow medical. Life does not follow medical</p> <p>Recertification at renewal: At the carrier's discretion</p>
	<p>Must be the sole carrier</p> <p>Cases must be submitted to CalChoice by 12/17 midnight and approved by 12/31</p> <p>Contingent approvals will be allowed</p> <p>Recertification at renewal: At the carrier's discretion</p>
	<p>Does not require to be the sole carrier</p> <p>Cases must be received by Health Net by 5:00 pm on 12/17 and must be approved by 1/22</p> <p>Recertification at renewal: At the carrier's discretion</p> <p>Ancillary coverage will follow normal guidelines for participation and contribution</p>
	<p>Does not require to be the sole carrier</p> <p>Cases must be submitted to Kaiser by 12/15 midnight</p> <p>Recertification at renewal: Yes, to ensure group meets the definition of a small employer</p> <p>Ancillary coverage will follow normal guidelines for participation and contribution</p>
	<p>Does not require to be the sole carrier as long as the minimum 5 enrolled or 25% participation is met</p> <p>The case has to be submitted by 12/15 to the carrier by midnight</p> <p>Recertification at renewal: At the carrier's discretion</p> <p>Oscar is a medical only carrier</p>
	<p>Must be the sole carrier</p> <p>Sharp will write alongside a cross border plan (considered valid waivers)</p> <p>Case must be received by 12/14 by midnight and approved by 12/15 - no exceptions</p> <p>Recertification at renewal: At the carrier's discretion</p>
	<p>Does not require to be the sole carrier with staff model carrier (can write alongside two staff model carriers)</p> <p>Requires at least 5 CA employees to enroll with UHC if writing alongside another carrier</p> <p>Must be complete at submission with all requirements in by 8:59 pm on 12/17 – no exceptions</p> <p>Recertification at renewal: Yes, to ensure group meets the definition of a small employer</p>
