

Definition of Terms



Participating Physician Group (PPG)

A group of doctors, set up as a legal entity, that has an agreement with Health Net to provide medical care to Health Net members. PPGs are sometimes referred to as a

"contracting physician group" or a "medical group." An individual practice association may also be a PPG.

Primary Care Physician (PCP) A doctor who manages and directs the delivery of covered health care services and supplies to the member. PCPs include general and family practitioners, internists, pediatricians, obstetricians and gynecologists.



Participating Hospitals

A member's PCP may need to refer them to a hospital for further care.

The PCP will refer the member to a hospital where the PCP has admitting privileges. Log in to www.healthnet.com/ProviderSearch for a list of hospitals where the PCP has admitting privileges. Note: Members must first contact their PCP for medical care and advice before they receive treatment through a hospital. The PCP must authorize hospital admission and treatment. In an emergency, the member should call 911 or go to the nearest ER.
